FROM THE EYEPIECE BY: MARK KAYE

Hello everyone. I had hoped to have all sorts of observations to report on. Instead, I have only a handful of night's worth. Mars has been a treat. The night of July 16th, the Moon slipped within a few minutes of Mars and the night was one of those uncharacteristic nights where it cleared at sunset and clouded over after sunrise. It was an entirely pleasant night, warm, but without bugs and a lazy celestial event carrying on. With Mars being so close to the Moon after sunrise, it was an easy feat to follow Mars in the daylight sky until both objects moved behind the trees in the west after eight in the morning. Every time I get a chance, I look at Mars, because some of the best views come on nights otherwise unsuitable for observing. The best night, as far as detail has been concerned, was the morning of August eighth. This has been the only occasion when I could run up to department store telescope power levels of 508X and still be able to see a sharp image. Hopefully, when Mars is closest, there will be some fine nights so that everyone can get out and have a good

But that is about it. Even the night of the power outage was not a good night for observing here. Haze and clouds and then the rising Moon made the night skies seem pretty much normal despite the lack of streetlight.

I attended the Vancouver General Assembly of the RASC held over the last weekend of June. This was the 100th anniversary of the Royal charter and the Lieutenant Governor of British Columbia, Iona Campagnolo, officially opened the proceedings on behalf of the Queen.

As meetings go, this was a quiet one. We voted to accept a brand new centre into the RASC, the Belleville Centre. That makes a total of 27 centres across the land. There is not going to be a price increase in membership this year as the society is in good financial standing. We approved the production of a fifth edition of the Beginners Observer's Guide (BOG) and it will be expanded, have a nicer cover, include more images and some colour images. A new publication is being created called "Skyways". This will be a publication for helping educators. A budget was approved and it is hoped that publication of the first edition will happen in the fall.

Four positions come up for renewal on the executive of national council: President, two Vices and Treasurer. Nominations must be in for these positions before the

end of April. The positions will be filled at the St. John's, NF, G.A. The 2005 G.A. will be held in May and be hosted by the Okanagan Centre.

We approved changes made to the Calgary and Moncton centre's by-laws. This means that Calgary will be opting into the membership system run by national, leaving Toronto centre as the only hold out to the flexible membership year system.

At the 02-10 meeting, a new insurance scheme was suggested by Toronto centre where all centres would be blanketed by the coverage of national at about a third of the cost. This turned out to be too good to be true. Due to changes in the insurance industries, what would have flown not even a year ago will not fly now and individual centres are going to have to continue getting insurance independently at their present costs.

The membership and promotions committee is playing with an idea to make the cover sheet for "Journal" and "Sky News" mailings into a multi-use printing. There will be six different cover sheets produced. The large part of the sheet will be the address, but a section on each sheet will be used to give each member a membership card, promote upcoming events, advertise the G.A. or promote upcoming events and sky happening. It is actually quite a clever idea that will take a sheet of paper that does one thing and cover a lot of useful ground.

At the annual general meeting, three bylaw amendments were voted upon. The Public Education and the Observing Committees had their status changed from special to standing committees. This means that these committees become part of the permanent committee structure, giving votes to the chairs at national meetings. A vote on whether or not appointed positions should be allowed to vote on council was discussed and this motion did not carry so committee chairs can still vote at council.

Finally, at the second council meeting, a committee was struck to overhaul the proxy process. It is hoped that a firm proxy policy can be come up with to hopefully end the recriminations caused by the use or ill use of proxies at general meetings.

I am sure that I have missed something, but I have gone on long enough as it is. I look forward to the fall and a new slate of centre meetings. September's meeting will be our annual member's night, so bring out a sample and talk about what you have done with our wonderful hobby over the last year. October's meeting will be our annual general meeting. Please consider

joining our council and helping out with the future of our fine centre.

Explore the Universe

"Explore the universe" is available to all RASC members especially beginners.

What is Explore the Universe? Explorer the Universe is an observing certificate program. This program is designed to provide the observer with a well-rounded introduction to the night sky.

Why should you get involved? Using this observing program is an excellent way to gain knowledge and experience in astronomy. This program will help introduce you to amateur astronomy and prepare you for other more challenging certificate programs such as *Messier* and *Finest NGC*.

Do I need a telescope to participate? No.

Binoculars are an ideal first observing instrument and this program has been designed so that it can be completed using binoculars alone. While a telescope can show many objects on this list in more detail, experienced observers always have a pair of binoculars handy.

Will I need a guide or a star atlas? Explore the Universe Observing Certificate program can be used in conjunction with *The Beginner's Observing Guide*. This

Annual General Meeting By: Grant Maguire

As stipulated by our by-laws our Annual General Meeting will be held in the month of October. This years' Annual meeting is on Thursday October 2, 2003 at 8:00 pm at the Hamilton Steam and Technology Museum. A new slate of directors will be elected at this meeting. Please take note of the following excerpts from the

to be received by the Secretary 10 days prior to the Annual General Meeting.

ARTICLE 5 - BOARD OF DIRECTORS

5.01 COMPOSITION

The Board shall be composed of twelve Directors, each of whom at the time of election and throughout the term of office must be a voting member of the Centre.

5.03 ELIGIBILITY

Every voting member has the right to stand for election or appointment to the Board provided that the member:

- (i) shall be eighteen years of age or older at the time of election or appointment,
- (ii) shall have been a member of the for one year or more at the time of election or appointment.

5.04 NOMINATIONS

Any member of the Centre may make nominations to the Board. Such nominations shall be submitted by the member to the Secretary of the Centre in writing at least ten (10) days before the annual meeting, and shall contain the name of the nominator and the written consent to the nomination by the nominee.

5.05 ELECTION OF DIRECTORS

(1) Where there are more than twelve nominations for the Board, the Secretary shall prepare a ballot listing in alphabetical order all eligible nominees

for which an election must be held at the annual meeting. A ballot will be distributed at the annual meeting to each voting member of the Centre in attendance or represented by proxy.

- (2) All marked ballots shall be counted by two scrutineers appointed by the members. The twelve candidates receiving the greatest number of votes shall be declared elected to the Board of Directors at the annual meeting.
- (3) Where there are no more than twelve nominations the Board shall be declared elected by acclamation.

5.06 TERM OF OFFICE

- (1) Each Director shall be elected to hold office until the next annual meeting.
- (2) The whole Board shall be retired at each annual meeting, but shall be eligible for reelection if otherwise qualified.

8.03 ANNUAL MEETINGS

- (1) The Centre shall hold an Annual Meeting of its members in the month of October.
- (2) At every Annual Meeting the report of the Directors and the Financial Statements for the Centre's previous fiscal year shall be submitted for adoption by the members.
- (3) If required, the auditors shall be appointed for the ensuing year and the remuneration of the auditors shall be fixed.
- (4) The election for the Board of Directors shall be held at every Annual Meeting.
- (5) At least ten (10) days before the date of the Annual Meeting the Secretary shall notify each voting member of the Annual Meeting specifying its time, place and agenda.
- (6) At any Annual Meeting of the Centre only such business as is specified in the agenda shall be conducted.
