I am always accessible to all members, anytime. Please feel free to call me or email me at president (at) hamiltonrasc (dot) ca. Les Nagy, President



**Mercury & Venus** – are both very difficult to observe this month for northern observers. They are visible in the early twilight for only a short time and Venus is only visible in the last half of the month.

Mars – moves from Virgo to Libra in the second half of the month. It's visibility improves over the month and it is low in the E SE morning twilight.

**Jupiter** – is in Virgo. Also low in the predawn ski and also improving throughout the month.

**Saturn** – is in Gemini. Stationary on Nov 8, it begins retrograde motion westward. Rising by 9.00 pm in the E NE it will be 60° high in the S SW by morning twilight.

#### Hamilton Centre on the Radio



# The Royal Astronomical Society of Canada Hamilton Centre 1968 Treasurer's Report 2003-2004

The 2003-2004 financial year was another successful year for the Hamilton Centre. The highlight of it had to be our receiving a Trillium Grant for the sum of \$75,000. With this money we were able to purchase a new 16" Ritchey-Chretien telescope, Software Bisque Paramount, CCD camera, and digital projector for use at out monthly meetings.

The following table summarizes our revenue and expenditures for the year. As much of the money we spent was in US dollars, and as we continue to hold a US dollar account, a conversion rate of 1.3047 to 1 was used to simplify our expenditures and holdings.
